

**VOLUNTARY AGREEMENT AND  
MINOR'S LIABILITY RELEASE  
FOR VOLUNTEERS AGED UNDER 18**

**BRAZOS CHURCH PANTRY**

I represent and acknowledge that my child or ward under 18 years of age is volunteering to serve in the programs and ministry of BRAZOS CHURCH PANTRY. He/she will pay his/her own expenses and assume all risks related to the work. The work at times may be somewhat arduous and will be performed by my child/ward, and with other volunteers in the work of BRAZOS CHURCH PANTRY.

For and on behalf of myself, my child/ward, heirs, administrators, and executors, I hereby release and discharge from liability BRAZOS CHURCH PANTRY, its Board Members, its Executive Director, its employees and its representatives, and their successors or assigns, from any claims, demands, damages, actions, or causes of actions which I or my child/ward have or may have in the future on account of, or any way growing out of injuries or damages both to persons or property resulting or that may result from his/her volunteer work.

I fully understand this release agreement, and I enter into it willingly for the purpose stated above.

**IT IS MY EXPRESS INTENTION, AND THE EXPRESS INTENTION OF THE RELEASED PARTIES, THAT THE RELEASE PROVIDED FOR IN THIS AGREEMENT RELEASES THE RELEASED PARTIES FROM THE CONSEQUENCES OF THE ACTS OR OMISSIONS OF THE RELEASED PARTIES, INCLUDING ACTS OF NEGLIGENCE OR ALLEGED NEGLIGENCE.**

By completing and submitting this form to BRAZOS CHURCH PANTRY, I understand and agree to the following:

1. I understand that by definition, as a volunteer, my child/ward will receive no wages for his/her actions or commitments at BRAZOS CHURCH PANTRY.
2. I understand that pictures may be taken while volunteering, and I grant full permission for BRAZOS CHURCH PANTRY to use photographs taken during my child's/ward's service as promotional assets (e.g. website, posters, flyers, etc).

By signing below, I declare that I have read, comprehend, and agree to the terms of this agreement, and I and my child/ward am legally bound by its terms. This release will remain valid and enforceable, regardless of the number of times the volunteer named herein participates in activities, unless revoked in writing by me. I further understand that once the volunteer turns 18 years of age, an adult Liability Release form must be completed.
